

**SUBJECT: Express Ukrainian Call for Proposals for the European Space Agency's
Business Incubation Centre in Portugal - ESA BIC Portugal**

As part of its endeavour to encourage the transfer and commercialisation of space technologies, the European Space Agency¹ (the Agency) has set up business incubators located in Noordwijk (The Netherlands), Darmstadt (Germany), Lazio (Italy), Bavaria (Oberpfaffenhofen, Nuremberg, Berchtesgadener Land and Ottobrunn, Germany), in Harwell (United Kingdom), in Redu and Flanders (Belgium), in Toulouse and North France (France), in Stremayrgasse (Austria), in Zurich (Switzerland), in Madrid and Barcelona (Spain), in Prague (Czech Republic), Tallinn and Tartu (Estonia), in Uppsala (Sweden), in Athlone, Cork and Maynooth (Ireland) and in Portugal (Aveiro, Braga, Coimbra, Covilhã, Évora, Faro, Funchal, Ilha Terceira, Lisboa, Matosinhos, Porto, São João da Madeira, Santa Maria e São Miguel). Their purpose is to enable entrepreneurs to receive comprehensive commercial and technical assistance in order to set up their businesses using space technology for non-space industrial and commercial uses.

Instituto Pedro Nunes (IPN) is entrusted by the Agency with this specific call's set, administration, and implementation.

Your attention is drawn to the following:

Nature and purpose of this Call for Proposals:

1. This **Express Ukrainian Call for Proposals (Call)** aims to select projects and ideas for business incubation in the ESA BIC Portugal.
2. The Agency offers to support projects and ideas for business incubation by providing funding, business and technical assistance, and office accommodation & services. The extent of the support provided is negotiated on a case-to-case basis. As a general rule, the financial support granted to one project for its prototyping and IPR development will not exceed EUR 50.000,00.
3. This is an express Call, due to accepting applications from 30/04/2022 until 26/05/2022.
4. Applications to this **Express Ukrainian Call for Proposals (Call)** are only eligible if timely submitted by 1) Ukrainian citizens or any individual possessing a residence permit in Ukraine for more than 5 months in the last 9 months; 2) Companies no older than 5 years from formal incorporation, as proven by any Ukrainian Commercial Registry official document, with certified translation to English or Portuguese, which had operated in Ukraine for more than 6 months in the last 9 months, as shown by evidence of the trade-in Ukraine.
5. In the case of formally incorporated companies, the company – duly represented by its authorized representative(s) – is considered to be the Applicant.
6. In the case of legal entities that are not registered, the individual acting as prime promotor is considered to be the Applicant.
7. In case the Applicant is an individual, (s)he shall be over eighteen years of age and fully empowered to be part of a binding agreement.
8. All the above categories are hereinafter referred to as ‘Applicant’.
9. This Call is aimed at Applicants who are developing technology from a space background but for non-space activities or domains (spin-off) or exploitation of non-space technology in the space market (spin-in), but explicitly excludes activities promoting, or being related to, alcohol, tobacco, religion, politics, intolerance, violence, firearms, pornography, obscenity, gambling or illegal drugs.
10. ESA BIC Portugal encourages Applications addressing relevant problems, needs or opportunities regarding the following thematic areas:
 - **“Blue Worlds” – socio-economic development of the Atlantic** namely, bay and estuarine areas incl. coastal ecosystems and processes and sustainable food production, maritime infrastructure, safety and security and low-cost sensors and information systems;
 - **Sustainable development;**
 - **Safe and secure communications, optical communications and 5G;** and
 - **Space Safety.**

This statement does not limit in any possible way the range of non-space markets or geographies of applications of the Applications submitted.

Requirements

11. Applicants are required to closely follow the instructions provided in this Call when producing and submitting their proposal (see section I of Call for Proposals – Appendix 1).
12. Only those Applicants that fulfil all formal requirements (see section II of Call for Proposals - Appendix 1) will be accepted for evaluation.
13. Applicants should carefully read the contractual documentation provided in section III of Call for Proposals - Appendix 1. The application shall include a clear, explicit and unambiguous statement whereby the Applicant has read and understood the terms and conditions contained in the contractual documentation and accepts them. In exceptional cases where the Applicant wishes to propose modifications or amendments, the full text of such modifications shall be given. The reasons for the amendments requested shall be clearly explained.

Procedure and planning

14. The evaluation of all proposals received shall take place in accordance with the Agency's and IPN's rules and procedures (see section II of Call for Proposals - Appendix 1). All Applicants will be informed of the outcome of their application.
15. The evaluation procedure is carried out jointly by IPN and ESA.
16. The ESA Tender Evaluation Board (TEB) shall meet to evaluate the proposals received in this specific. Proposals will be accepted for the evaluation round where they reach IPN within the dates and times published at <http://space.ipn.pt>
17. The period between the receipt of a proposal and contract placement is in principle no longer than 3 months.

Miscellaneous

18. The contents of the Applicant proposals shall be treated as confidential.
19. In spite of the efforts undertaken by IPN to ensure full confidentiality, the Applicant's idea may through the application with IPN (if not specifically protected for example by patent rights) fall into the public domain. Therefore, it is strongly recommended that the Applicant discusses the protection of his/her idea with a dedicated expert in this field prior to application with IPN.
20. As far as allowed by law, any title held by the Applicant to his/her idea shall remain vested in him/her. This application shall under no circumstances result in the acquisition of any title whatsoever to the ideas.
21. No expenses incurred in any stage of the application procedure will be reimbursed to the Applicant by IPN, the Agency and/or any third party.

If the Agency or its Member States require the use of Intellectual Property Rights related to the product or service being developed during the incubation programme, owned by the Incubatee as described in Item 20 here above for the performance of the Agency's programmes in the field of space research and technology and space applications, ESA will issue a tender in direct negotiation to the incubate. If the Incubatee is not willing or able to perform the activity for the Agency, the Agency or its Member States shall be entitled to a free of charge, transferable, non-exclusive licence to use such Intellectual Property Rights, which licence shall be

limited to the territories of the Agency's Member States.

22. In no event shall this Call for Proposals be construed as imposing any obligation whatsoever upon IPN, the Agency and/or any third party to enter into negotiations with any Applicant or to enter into any other specific arrangement for business incubation in any of the ESA BICs' and IPN's establishments.
23. IPN and the Agency are committed to ensuring equal opportunities and the elimination of discrimination of any type for all applications complying with the conditions and requirements set forth in this Call.
